Note 3

The chair of the society is Roger Hinton who has indicated that he will be standing down at the 2019 AGM. The honorary secretary is Richard Carroll who was re-elected in 2016 and is therefore required to stand down at the 2019 AGM; he has indicated that he will not be standing for re-election

Note 4

In accordance with the constitution and adopted election rules, a notice must invite members to nominate candidates for election and specify a period of not less than fourteen clear days from publication of the notice for such nominations to be received by the honorary secretary. The nomination form is attached.

Information about the candidates will be published on the society's website as soon as practical and in any event not less than seven days before the meeting.

Note 5

In accordance with the constitution and the adopted election rules, to be nominated for election as an officer or a committee member a person must be a member of the society, must be proposed in writing by another member and the nomination must reach the honorary secretary by **5 pm on Saturday 16 March** at the latest. Unfortunately, Richard Carroll, the society's current honorary secretary is indisposed. Roger Hinton will act as honorary secretary until the AGM when a new holder of the post will be elected.

Nominations may be submitted on paper by post to the address given in note 2 above or as scanned, email attachments to chair@regencysociety.org.

Any nomination will only be valid if it is accompanied by the following items in writing:

- A statement signed by the nominee to show his or her willingness to be appointed
- A *fit and proper person* declaration signed by the nominee
- A personal statement of not more than 125 words consisting of a short biography of the nominee setting out his or her relevant qualifications and / or experience
- A personal statement of not more than 125 words consisting of an explanation of how the society would benefit from his or her appointment
- This applies both to existing trustees who wish to put themselves forward for re-election, and to any new nominations for election as officers or committee members.

- Published a book by Steve Myall and Andy Grant about some of the people involved in local printmaking and its history.
- Started a project to improve the James Gray collection – thanks to Mary McKean, Kevin Wilsher and the team of volunteers.

- Thanks to all those members who have renewed during the year
- Thanks also to those who have helped distribute membership leaflets
- And particular thanks to Suzanne Hinton, our membership secretary who works hard to keep the membership numbers up.
