Report of the trustees for the year ended 31 December 2022

The Society's charitable objects are:

- (1) to promote for the benefit of the public, the conservation, protection and improvement of the physical and built environment of the City of Brighton and Hove and the surrounding area.
- (2) to advance the education of the public in the history, conservation, protection and improvement of this physical and built environment.

The work of the Society has been less disrupted by the Covid 19 pandemic in 2022 than in the previous two years and activities have mostly returned to normal since the spring.

Conservation, protection and improvement

Our Planning Forum, which is run jointly with Hove Civic Society, resumed its work in June, initially via email but in face-to-face meetings later in the year.

Two trustees, including one who stood down at the AGM in April, continued to be members of Brighton & Hove City Council's Madeira Terraces advisory committee. With some reservations about the proposed new lifts, we supported the planning application for the first of the four planned phases of restoration.

We welcomed the proposed development of 212 new homes in eight blocks at Hodshrove Lane as a major contribution to the need for affordable housing in the city, and the redevelopment of the Enterprise Point and Melbourne Street site, which will provide a considerable boost for the city's need for co-living and co-working places.

We have followed proposals for the development of the gasworks site in Kemp Town as a member of a coalition of local amenity societies and joined in objecting to the inappropriate planned massing and over-development of the site. Jointly with Hove Civic Society we objected to the proposed replacement of a secondary school by more housing in the plans for Toads Hole Valley.

We were invited to a presentation by U+I about the proposed development at Moulsecoomb Place. Although the plans were thought sympathetic to the restoration of the Grade II historic buildings, again we were concerned about the overdevelopment of the site, including the proposal for a 15-storey residential block on an already elevated position adjacent to Moulsecoomb railway station. We were also invited to tour the completed development at Circus Street.

We objected to the proposed siting of 5G communications masts opposite Brunswick Terrace and adjacent to St Nicholas' churchyard. The Trustees failed to reach a consensus about the revised planning application for the Hippodrome.

Advancement of education History

Our project to improve the accessibility and usefulness of the James Gray photographic collection has continued during the year, thanks to the hard work of a committed team of volunteers. The results were presented as part of the lecture programme (see below).

Events

Two lectures were presented online in real time: Kathryn Ferry on Eugenius Birch: The King of Piers on 19 January 2022 and Jackie Marsh-Hobbs about Brighton Aquarium on 16 March 2022. The lecture on 23 February 2022 was at the Friends Meeting House, shared by Helmut Lusser, chair of Hove Civic Society, and Diane Smith, a trustee of the Town & Country Planning Association and founder of Brighton & Hove 20 Minute Neighbourhood, on the theme of Beautifying the City.

The Annual General Meeting (see below) was followed by the John Small Lecture: trustee David Fisher's illustrated historical review of places associated with Drink in Brighton.

On 16 July we held a garden party in the Kemp Town Secret Garden. Some 60 guests enjoyed good weather, good refreshments and good conversation. We were pleased to welcome specially invited guests, including the city's mayor, Councillor Lizzie Dean, and the MP for Brighton Kemp Town, Lloyd Russell-Moyle.

The 2022/23 season began with the delayed Antony Dale Lecture on 28 September 2022, held as usual in the Music Room at the Royal Pavilion. Restoration of the Madeira Terrace was the subject for Lian Harter from the consultants Purcell. It was followed by drinks in the banqueting hall.

A new venue was arranged for lectures: The Hove Club, the 1897 Grade II listed building in Fourth Avenue, fittingly designed by Samuel Denman, the father of John Leopold Denman, one of the founders of the society. Unfortunately, the first lecture there, on Seaside Hotels, due in October, had to be postponed at short notice owing to the indisposition of the speaker. The programme resumed on 16 November 2022 with a talk by Kit Wedd, a trustee of the Victorian Society, on The Victorian House. On 14 December 2022 Mary McKean introduced the new version of the website for the society's James Gray Photographic Collection.

Many thanks are due to all our speakers for returning us to the traditional way of presenting our lectures.

Membership

As at 31 December 2022 the Society had 325 members (341 in 2021), as listed below. The reduction in membership numbers had occurred mainly while the pandemic continued. However, 32 new members have joined since July, when we returned to regular events. We recover Gift Aid on members' subscriptions when possible.

We have continued to keep members informed about our activities through monthly news updates.

We were saddened to learn that John Small died at the end of December. He had been a member since 1979 and was a trustee in 1983/84 and again from 1992 to 2009. He became honorary secretary in 1995 and held that post until 2009. The lecture that follows the AGM is named in his honour. We also lost Derek Granger, who died in December at the age of 101; he had been one of our vice-presidents since the closing years of the previous century.

Governance and finance

The annual general meeting was held on 3 May 2022. Mary McKean's term of office as chair came to an end. As she is moving away from Brighton, she decided not to stand for re-election as chair, nor to remain as a trustee. Alasdair Glass and Jamie Wright stood down as trustees. They were all thanked for the contributions they had made to the society. David Fisher was elected chair and Roger Hinton re-elected as honorary secretary and Helen Walker as a trustee.

The committee of trustees met formally 11 times during 2022, the year's meetings being split between those in person and those online.

The financial statements for the year are shown on the following pages. The trustees reviewed the reserve funds, and investment policies during the year. We are grateful to Stephen Pavey who has served for several years as our independent financial examiner. Steve is a Regency Society member and undertakes the role on a voluntary basis.

During the year we were very grateful to receive a donation of £4,000.00. This was a bequest from the late Alfred Thompsett, who had been a long-standing member.

Trustees

The constitution of the society allows for up to 14 trustees. We began the year with nine trustees. As well as the two who stood down at the AGM in May, Angela Devas resigned in August. She too is thanked for her contributions to the society.

The committee co-opted Catherine Page and Desmond Lavery as trustees. As there are still vacancies, the trustees are keen to encourage anyone interested to join us.

Funding

The lecture programme and publications are available largely free of charge to members and equally to the public; they are funded from members' subscriptions and other revenues.

Reserves

The trustees have designated three unrestricted reserve funds for purposes directly related to the Society's charitable objects:

Campaigning fund: a reserve to meet the cost of campaigning for or against proposed development activity, which the trustees consider likely to improve or to damage the city's physical and built environment. During 2022 the fund was not used and currently stands at £24,000.

Conservation and improvement fund: this reserve is held for use in supporting projects that the trustees believe will conserve, protect or improve the city's physical and built environment. It was not drawn on during 2022 and currently stands at £24,000.

Education fund: this reserve is held to enable the Society to subsidise events designed to educate the public in the history, conservation, protection and improvement of the city's physical and built environment. As mentioned above, the cost of the Society's educational activities is met largely from annual revenue. The education fund is held to meet the cost of any significant additional educational

activity that cannot be fully funded in the usual way. It has not been drawn on during 2022 and currently stands at £12,000.

Now circumstances have returned to normal, the trustees will be seeking appropriate opportunities to apply these funds.

Heritage assets

The Society owns a small number of heritage assets, the most notable being the James Gray photographic collection. There is also a small collection of other historic artworks and artefacts owned by the Society, which are on loan to the Brighton Royal Pavilion and Museums Trust. We agreed to a request from the Trust to move a bust of George IV to storage in order to accommodate the display of a painting by John Constable on display in the Royal Pavilion until it moves to the Museum.

Property

The Society owns the lease on a storeroom in Regency Square, Brighton. It is held in trust for the Society by the Official Custodian of Charities. It is currently empty, and the Society's archives are now held partly at The Keep and otherwise in a secure storage space provided by one of the trustees. Trustees have obtained a valuation for the storeroom and are hoping to dispose of it by auction during 2023.
